I. CALL TO ORDER

III. ELECTION OF SILETZ AREA ENHANCED LAW ENFORCEMENT DISTRICT BUDGET COMMITTEE OFFICERS

A. Chair

Commissioner Hall nominated Mayor Worman as chair. Lisa Norton seconded the motion. Mayor Worman was elected Chair.

B. Vice Chair

Commissioner Miller nominated Lisa Norton as Vice Chair. Wylie Stokes seconded the motion. Lisa Norton was elected Vice Chair.

A. Meeting of the Siletz Area Enhanced Law Enforcement District Budget Committee to present the Budget Message and to take public comment on the Siletz Area Enhanced Law Enforcement District Budget for FY 2025-2026 - Presented by Lt. Karl Vertner

Lt. Vertner walked the committee through a series of slides illustrating the operations of the Law Enforcement District for the past year. Sheriff Shanks joined him in addressing questions from the committee and audience.

A. Motion on Siletz Area Enhanced Law Enforcement District Budget

Lisa Norton moved to amend the Siletz Area Enhanced Law Enforcement Service District FY 2025-26 budget to create a line item for overtime payment for officers not to exceed \$5,000 and to add \$2,500 to the existing line item for National Night Out. Wylie Stokes seconded the motion. The motion carried. Lisa Norton moved to approve the Siletz Area Enhanced Law Enforcement Service District FY 2025-26 budget as amended by this Committee and to authorize a property tax levy at the permanent tax rate of \$1.31 (one dollar and 31 cents) per thousand and that these taxes be imposed and categorized for the

tax year 2025-26 upon the assessed value on all taxable property within the District in accordance with law as of July 1, 2025. Mayor Worman seconded the motion. The motion carried.

Lisa Norton moved to adjourn the meeting. Wylie Stokes seconded the motion. The motion carried, and the meeting was adjourned at 6:54 p.m.
